

Terms of use of the Business Blog (BB) MARKET-UP

ATTENTION!

When filling out the blog header, we do not recommend writing contact information in your blog. You indicate all the necessary contact details in the vouchers that users buy from you. By this you not only increase your income, but also increase the interest of sellers in the sale of your vouchers.

VALUABLE WHAT HAS A COST!

When buying vouchers, each buyer automatically becomes a subscriber to the voucher author's blog. To increase sales, use and maintain your Business Blog more actively.

1. BUSINESS BLOG (BB) "MARKET-UP" is a territory free from politics.
2. All blogs when publishing posts on political topics will be blocked and deleted.
3. On the MARKET-UP platform, everyone has the opportunity to maintain a personal Business blog, talking about their business or favorite pastime.
4. BB can be run by completing a free Short Registration. (Extended is intended for the formation of subscriptions for discounts).
5. On the MARKET-UP platform, referral links are used thanks to the links and the ID of the inviter.
6. When registering using the link or ID of the inviter, each user automatically becomes a subscriber to the blogs of higher program participants. Also, automatic subscription to the voucher author's blog occurs at the time of purchase of vouchers.
7. The participant understands and at the time of his transition to the address www.market-up.co, using a web browser or any other program and / or technical devices that make it possible to display the content of the site's web pages, confirms its agreement with the automatic subscription to the blogs of higher program participants, as well as to the blogs of authors who have formed vouchers.
8. If you do not want to receive news information in the news feed on your blog from higher program participants or voucher authors, you can unsubscribe from the automatic subscription by clicking the "Unsubscribe" button on the blog.

9. The following is prohibited in publications on the site:
- inciting hatred on social, national or religious grounds;
 - calls for violence or any other violation of the law;
 - distribution of 18+ content;
 - calls or "instructions" for suicide;
 - propaganda or distribution of drugs.
10. The Site Administration may, but is not obliged to, view the Site at its sole discretion, for any reason or no reason, including, without any restrictions, moving or deleting Content that, in the personal opinion of the Administration, violates these Rules, the law and / or may violate the rights harm or endanger the safety of other Users or third parties.
11. Third Party Content.
- 11.1. The Site contains (or may contain) links to other sites on the Internet (third party sites), as well as articles, photographs, illustrations, graphics, music, sounds, videos, information, applications, programs and other Content owned or coming from third parties (Third Party Content), which is the result of intellectual activity and protected in accordance with the laws of the country where the site is used.
- 11.2. These third parties and their Content are not checked by the Administration for compliance with certain requirements (authenticity, completeness, integrity, etc.). The Administration is not responsible for any information posted on the websites of third parties to which the User accesses through the Site or through the Content of third parties, including, but not limited to, any opinions or statements expressed on the websites of third parties or in their Content.
- 11.3. The links or instructions for downloading files and/or installing third-party programs posted on the Site do not mean support or approval of these actions by the Administration.
12. A link to any site, product, service, any information of a commercial or non-commercial nature posted on the Site does not constitute an approval or recommendation of these products (services) by the Administration.
13. If the User decides to leave the Site and go to third-party sites or use or install third-party programs, he does this at his own risk and from that moment these Rules no longer apply on the User.
- In further actions, the User should be guided by applicable rules and policies, including the business practices of those persons whose Content he intends to use.
14. Operation of the MARKET-UP Site and responsibility for its use.
15. Users are responsible for their own actions in connection with the creation and placement of information on their own personal page on the Site, as well as in connection with the placement of information on the personal pages of other Users

and in other sections of the Site in accordance with applicable law. Violation of these Rules and current legislation entails civil, administrative and criminal liability.

16. The Site Administration provides the technical possibility of its use by the Users, does not participate in the formation of the content of the Users' personal pages and does not control and is not responsible for the actions or inaction of any persons in relation to the use of the Site or the formation and use of the content of the Users' personal pages on the Site.
17. There are no technical solutions in the information system of the Site and its software that automatically censor and control the actions and information relations of Users on the use of the Site, with the exception of special technical solutions that can be implemented by the Administration in order to prevent and suppress violations of the rights of third parties to the results of intellectual property. activities.
18. The Site Administration is not engaged in preliminary moderation or censorship of User information and takes actions to protect the rights and interests of persons and ensure compliance with the requirements of the law only after the request of the person concerned to the Site Administration in the prescribed manner.
19. The Site Administration is not responsible for violation of these Rules by the User and reserves the right, at its own discretion, as well as upon receipt of information from other users or third parties about the violation by the User of these Rules, to change (moderate), block or delete any published by the User information that violates the prohibitions established by these Rules, suspend, restrict or terminate the User's access to all or any of the sections or functionality of the Site, exclude from the search system and / or block the Community at any time for any reason or without explanation, with prior notice or without it. The Site Administration reserves the right to block the User's personal page and / or suspend, restrict or terminate the User's access to any of the Site's functionality if the Administration finds that, in its opinion, the User poses a threat to the Site and / or its Users.
20. Along with the above in this paragraph, the Site Administration has the right to block and / or delete API Applications, restrict Users' access to API Applications, websites, third-party applications, other third-party resources, block and / or delete links to them, if the Site Administration will have reason to believe that such API Applications, websites, third-party applications, other third-party resources pose or may pose a threat to the normal operation of the Site and its Users. The Site Administration implements the measures described above in accordance with applicable law and is not responsible for the possible negative consequences of such measures for the User or third parties.
